³ SSS 2 Year Old Western Pleasure will pay \$2000 to winner. See payback chart for amounts in rule section.

⁴ SSS 3 Year Old Western Pleasure purse is **a minimum of \$1000**. Purse amount could increase due to a residual amount in the SSS 2 Year Old WP.

- All classes require current **MQHA Membership** for owner and exhibitor.
- All NSBA classes require current memberships for owner and exhibitor.
- All NSBA classes require current NSBA Registration.
- All classes require breed registration papers by the day of the class, or payouts will be withheld until submitted.
