All Futurity and SSS Classes require a current MQHA Membership for both owner and exhibitor.

All fees listed are one-time payments with the electronic date or postmark to control the amount. Fees increase after the due date. Electronic, emailed and faxed entries with payment by or on due date will be accepted as timely. *Fees include NSBA class sanction fee where applicable.*

SSS Classes (S1 – S9)

- ❖ These classes are closed to either mare or stallion owner entries. Mare owner entries must be the resulting foal from a breeding purchased through the MQHA Stallion Service Sale. Stallion owner entries are authorized by the stallion owner. Please contact the MQHA office if you are unsure of eligibility.
- ❖ All classes require current MQHA membership for owner and exhibitor.
- ❖ All classes require breed registration papers by the day of the class, or payouts will be withheld until submitted.
- ❖ Class S7, the SSS 2-Year-Old Western Pleasure will pay a maximum of \$2000¹ to winner. See payback chart below.
- ❖ Class S8, the SSS 3 Year Old Western Pleasure purse will be **a minimum of \$2827¹**. The purse amount *may* increase due to residual money in the SSS 2-Year-Old Western Pleasure.

Futurity Classes (F1 – F24)

- ❖ All classes require current MQHA membership for owner and exhibitor.
- ❖ Futurity classes F1 – F24 are open to all horses with no eligibility requirements.
- ❖ All classes require breed registration papers by the day of the class, or payouts will be withheld until submitted. Any breed horse that is eligible to be registered with NSBA or WCHA is eligible to be entered.
- ❖ Ownership requirements must be met in the Non-Pro classes.
- ❖ ²Junior division cut off – weanlings born March 1 or later are eligible for the concurrent Junior class. The highest placing junior baby in each class will win a trophy buckle and a junior division payout of \$100 in addition to any futurity payout earned.
- ❖ ³In keeping with the industry standards, the Futurity (F9) two year old western pleasure and Futurity (F10) two year old hunter under saddle will no longer be offered at this event beginning in 2027. This does NOT affect the SSS two year old western pleasure (S7).
- ❖ All NSBA classes (F5 – F24) require current NSBA memberships for owner and exhibitor.
- ❖ All NSBA classes require horses to have or to purchase a NSBA Registration.
